A deposit for each set as stated above will be required as a guarantee of the safe return of the documents within fourteen (14) days of bid opening. This deposit will be refunded in full if the documents are returned in good condition. A separate nonrefundable charge of Fifteen Dollars (\$15.00) is required to cover the cost of ground shipping.

A non-mandatory pre-bid conference will be conducted on Thursday, March 27, 2008, at 10:00 a.m., local time, at corner of Walnut Avenue and Jefferson Street, SE.

Claims for withdrawal of bids shall only be made within two (2) business days after the opening of bids as set forth in part (i) of Section 2.2 - 4330 (A), Code of Virginia (1950), as amended.

The City expressly reserves the right to cancel and/or reject any or all bids, to waive any informality or irregularity in the bids received, and to accept a bid which is deemed to be in the best interest of the City.
